LIABILITY WAIVER AND RELEASE OF CLAIMS

(State of Ohio – Governing Law)

In consideration for being permitted to participate in the Bucc Boosters 3-on-3 Basketball Tournament (“Event”), I, on behalf of myself and/or the minor participant listed below, agree as follows:

1. Assumption of Risk

I understand that participation in basketball and related activities involves inherent risks, including but not limited to: falls, collisions, contact with other participants, equipment failure, overexertion, and negligent acts of other participants. These risks may result in serious bodily injury, permanent disability, paralysis, illness, or death.

I knowingly and voluntarily assume all such risks, both known and unknown, even if arising from the negligence of the Released Parties (as defined below), to the fullest extent permitted under Ohio law.

2. Release and Waiver of Liability

To the fullest extent permitted by the laws of the State of Ohio, I release, waive, discharge, and covenant not to sue:

- **Bucc Boosters**
- **Covington High School Basketball Program**
- **Covington Exempted Village Schools**
- **Event directors, officers, board members, volunteers, coaches, referees**
- **Sponsors and facility providers**

(collectively referred to as the “Released Parties”)

from any and all claims, demands, losses, or liability for any injury, disability, death, or property damage arising out of or related to participation in the Event, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASED PARTIES OR OTHERWISE, except for conduct that constitutes willful or wanton misconduct under Ohio law.

3. Indemnification and Hold Harmless

I agree to indemnify and hold harmless the Released Parties from any loss, liability, damage, or costs, including attorney fees, arising from my (or the minor participant’s) participation in the Event.

4. Medical Authorization

I authorize the Released Parties to obtain emergency medical treatment for the participant if deemed necessary. I understand that I am financially responsible for any medical expenses incurred.

5. Code of Conduct

I agree that the participants will abide by all rules and standards of conduct. The Event organizers reserve the right to remove any participant or team for unsafe or unsportsmanlike behavior without refund.

6. Media Release

I grant permission for photographs and video recordings taken during the Event to be used by the Bucc Boosters or Covington High School Basketball Program for promotional or educational purposes without compensation.

7. Governing Law and Severability

This agreement shall be governed by and interpreted in accordance with the laws of the State of Ohio. If any portion of this agreement is found unenforceable, the remaining provisions shall continue in full force and effect.
